The court has issued its findings of fact and conclusions of law this date and hereby renders its judgment.

It is adjudged and decreed that the defendants, their agents and employees are enjoined from holding, processing, or in any way conducting the plebiscite and referendum on the Compact of Free Association now set for February 10, 1983, with the ballot wording set forth in the printed ballot which is described in plaintiffs' Exhibit 1 in this action.

The election shall proceed to be held on February 10, 1983, and the defendant shall cause to be printed and distributed new ballots to all eligible voters. The form of the ballot to be used for the plebiscite and referendum on the Compact of Free Association shall be in the following form:
